September 08	Exhibitor Directory Entry	Upload your free 70-word directory entry with your company details.	MANDATORY FOR ALL EXHIBITORS
September 27	Exhibitor Badges	Register your onsite team for passes.	MANDATORY FOR ALL EXHIBITORS
October 2	Onsite Contact	This representative will be the main point of contact for Organizer communication throughout the duration of the event.	MANDATORY FOR ALL EXHIBITORS
September 16	Delegations	You are invited to scan the list of countries/organizations that you would like to connect with.	OPTIONAL
September 27	Safety Induction	Limited access during the construction phase is available to Exhibitors requiring use of a fork lift or custom build duties.	OPTIONAL
